# **GCPA FUNDS DISTRIBUTION GUIDELINES**

The GCPA/GCPA Foundation Funds Distribution Committee shall consider all funds distribution applications with the following exceptions:

- Funding requests from political organizations will not be considered.
- Funding requests to pay salaries will not be considered.
- Incomplete applications including not sending requested number of copies

Funding requests must support the GCPA/GCPA Foundation Mission and Goals (see below). Each funding request will be evaluated based on the degree to which it aligns with our mission.

The GCPA/GCPA Foundation Funds Distribution Committee will present the results of its evaluation, including its funding recommendations, to the GCPA general membership. The GCPA general membership shall vote to approve/disapprove the recommendations of the Committee. Applicants will be notified in writing of decision.

The GCPA/GCPA Foundation Funds Distribution Committee is not obligated to recommend distribution of any funds request. Available funds vary each operating year.
